

## Local Policy Questionnaire

Answer the following questions about the local policies below:

### Policies Within City and County Government

All La Plata County departments, offices, and division shall use, and require their contractors to use, products and services that are available locally whenever cost effective and to the extent practicable.

All La Plata County employees, who work in county-owned buildings that are served by La Plata County Buildings and Grounds Maintenance staff, shall be required to recycle.

The Durango Public Library charges the following for overdue materials: 10¢/day per item for all materials, with a maximum of \$4 per item.

All 501(c)3 non-profits receive \$60.00 worth of space rentals per calendar year at the Durango Public Library

Durango 9-R school district staff shall work with local farmers to provide local produce and other locally produced foods at the school sites.

Vehicles having three unpaid parking citations that are over 20 days old will be placed on the boot list. Once a vehicle is booted, all outstanding parking citations plus a \$50 boot fee must be paid before the vehicle will be released.

The launching or use of motorized craft on the Animas River within the city limits is prohibited. This prohibition shall not apply to craft utilized for purposes of emergency response.

The licensing and operation of retail marijuana cultivation facilities and retail marijuana product manufacturing facilities are hereby permanently prohibited and banned within the city.

Because of existing vehicular and pedestrian congestion along streets and sidewalks within the public right-of-way in the central business district, vending shall be prohibited within the central business district except on days designated for vending on a calendar to be developed and presented to the city council for its review and approval on an annual basis.

Any person who shall build, construct, reconstruct, alter, expand, modify or improve any building, dwelling, other structure or improvement to real property within the city shall, in conjunction with the acquisition of a building permit, pay an amount to the city equal to three (3) percent of fifty (50) percent of the estimated cost of the construction for which a building permit is requested.

The City of Durango shall establish a food tax rebate program within the city to reduce the burden of the city's sales taxes on low income families.

There is hereby established a segregated fund of the city to be known as the "open space, parks, and trails fund." From and after July 1, 2005, increased tax revenues received by the city from raising the sales tax to three percent will go into said fund.

There is hereby imposed a lodgers' tax of two (2) percent of gross taxable rent for lodging paid to vendors from and after June 1, 1980.

Poultry shall be prohibited in the city except in the Residential- Agricultural (R-A) zone; provided, however, that chicken hens numbering six (6) or fewer may be kept pursuant to section 10-1-30 of this Code
